Hi!

Please accept this email as conformation that we have spoken to most of the people on the list you supplied and have left messages for the people who did not answer. In addition to the people who we reach by phone to advise them we were mailing them application, we also mailed an application to the people we could not reach by phone. We have started to receive some from the list you supplied & am expecting all application to be submitted for processing by 10/11/19.

We have processed many application and currently there are 19 people approved for the lottery. In order for lottery winning tenants to give 30 days notice to there landlords the lottery will have to be in late October for occupancy in November. All section 8\* tenants are required to have there unit inspected prior to a move in which may delay a section 8\* tenants move in until December. To prevent any financial hardship on the developer we are requesting a Lottery Date & time for October so we can published the date in the month of October .
