Awarding, Amending and/or Rejecting of Bids

9A. Awarding contract for the Village Park Pole Replacement to HBC Company in the amount of \$79,740. Four bids were received.

9B. Awarding contract for the 2019 Concrete Improvement Program to S. Batata Construction in the amount of \$422,015.00. Six bids were received.

Introduction of Ordinances

10A. An ordinance amending *Chapter 435* of the Code entitled "*Vehicles and Traffic*" which will reduce the speed limit on Federal City Road to 35 mph (from 45 mph) for its entire length. Due to safety concerns, the Municipal Engineer along with the LTPD make this recommendation after a full examination was conducted (i.e., study of existing speed limits, speed data, crash statistics, roadway characteristics and adjacent residential uses).

10B An ordinance amending *Chapter 435* of the Code entitled "*Vehicles and Traffic*" which will reduce the speed limit on Eggert Crossing Road to 35 mph (from 40 mph where designated) for its entire length except for the reduced speed to 25 mph in the school zone remains. Due to safety concerns, the Municipal Engineer along with the LTPD make this recommendation after a full examination was conducted.

10C An ordinance providing for a *Special Assessment for Service Line Replacements* and Authorizing the Mayor to execute a Shared Service Agreement with the City of Trenton. This is required for compliance with State regulations, and it relates to the water line replacement project being conducted by Trenton Water Works for its resident customers.

Adoption of Ordinances

11A. Amending *Ordinance 2319-19* Salary Ordinance of the Township of Lawrence-Unclassified and/or Exempt, Seasonal, Emergency (non-union) employees for 2018-2019.

11B. Adopting a Codification and Revision of the Ordinances of the Township of Lawrence.

11C Amending the Administrative Code of the Township – Meetings of Council. Start time change for June, July and August 2019 will be 6:00 pm.

11D. Authorizing the private sale of certain lands of the Township not needed for public use. The land is located at Johnson Ave. (Block 2301, Lot 19) and the sale will be to the contiguous land owner for \$1,575.

Resolutions

The agenda includes routine administrative authorizations as well as resolutions providing for refunds, accepting and releasing various bonds and releasing project escrow funds.¹

Items of note:

18E 1 References the NJDEP (HDSR) grant for the Pit Stop Service Station that will provide funding for the demolition of the existing structure on the property and further environmental study to determine remediation requirements.
