### Awarding, Amending and/or Rejecting of Bids

9A. Awarding bid to *Centrifugal Lining, Inc.* for drainage improvements. This work will be performed at Harney's Corner on Princeton Pike, Berwyn Place near Post 414, and Reeder Ave. There was only one bid for this work and the amount is **\$168,525**.

9B. Awarding bid to *Kane Communications, LLC* for the Bergen Street Pedestrian Activated Crosswalk Lighting System. There was only one bid for this work and the amount is **\$15,200**.

9C. Awarding bid to *Richard T. Barrett Paving Company, Inc.* for the Road Improvement Program (Phase 1) in the amount of **\$645,848.55**. Four bids were submitted.

9D. Awarding bid to *Absolute Fire Protection Company, Inc.* for 2 Class "A" Pumpers (fire apparatus) for a total amount of \$1,164,184 (\$582,092 each). With additional warranty options selected, the total cost is **\$1,177,027**. There were 4 bidders. One bidder was over the Township budget and of the three remaining bidders, Absolute Fire Protection Company was the lowest responsible bidder.
