Call to Order: The meeting was called to order by Chairman, Dale Robbins at 7:32pm.

MINUTES: The committee reviewed the regular monthly meeting minutes for February 10, 2009. A motion was made by Jack Oakley, and seconded by Chief Rob Santello to approve the minutes as written. All were in favor.

OLD BUSINESS

HEALTH REPORT: Carol Chamberlain reported that the last scheduled Bloodborne Pathogens training session was held last night. She also advised the Chiefs that new members are supposed to be trained within ten (10) days.

Carol reminded that Hepatitis vaccines are required and must be scheduled if members have not received the vaccine, or are still in need of the additional vaccines to complete the series.

EMERGENCY APPARATUS REPORTS: All Slackwood, Lawrence Road and Lawrenceville Fire Company apparatus are in service at this time. Jack Oakley reported that the Lawrence Township Emergency Services Ambulance 129-1 had a recall recently and Ambulance 129-3 had the vacuum pump repaired.

PUBLIC SAFETY COMMITTEE NEWSPAPER ARTICLES: Chief Posluszny reported that the article about bicycle safety was inadvertently not posted, but will be forthcoming. Chief Ray Nagy suggested that it be run in conjunction with the upcoming Bicycle Rodeo scheduled for May 9th.

FIRE SERVICES STRATEGIC PLANNING COMMITTEE: Chief Ray Nagy reported that manpower was discussed as well as quantifying equipment. They are currently discussing ways to quantify fire calls together.

FINANCIAL REPORTS: Rich Krawczun stated that he is still waiting for the report from the Lawrence Road Fire Company.

PSAP SYSTEM: Chief Posluszny reported that they were waiting for an infrastructure report, but the funding for this program has been eliminated.

Wayside Lane to Route 206: Chief Posluszny reported that the investigation has not yet been completed.

NEW BUSINESS

Right turns from Slack Avenue to Route 1: Greg Puliti stated that he received a complaint that vehicles are turning right on red from Slack Avenue, onto Route 1 and then using it as a shortcut to CVS Pharmacy.

PLAN REVIEWS

There were no plans to be reviewed by the committee at this time.

NEXT MEETING: The next month's meeting of the Public Safety Coordinating Committee will be held on Tuesday, April 14th, 2009 in the Manager's Conference Room.

ADJOURNMENT
