IV. Hardship Waiver Procedure Discussion:

Chairperson VanHise stated there is nothing new to report except an e-mail he received from Ms. Phillipi regarding they are still working with the State and municipal options. They want to do a presentation and requesting to be put on an upcoming agenda. COAH is telling Ms. Phillipi there are some options such as a down payment assistance, no interest loan; payments over time; however, it will require an ordinance to be adopted by Council.

Chairperson VanHise stated we have to wait until they appear before the Board to hear what they are going to say; however, we might not be able to take any action.

V. Status of Changes at State Level:

There have not been a lot of changes at the State level. The Court has ruled that COAH had to provide the process. The court ruled that the Governor did not have the right to abolish COAH, in but not of DCA. If the Court ruled that the Governor had the power to roll it back into the DCA, it would have changed the trust funds. COAH sent out new letters and had to August 2nd to respond. No decision on the third round rules.
