The following are the Minutes of a Regular Meeting of the Lawrence Township Council that was held on Tuesday, November 6, 2014 at 6:30 P.M.

The meeting was opened with the Inspiration and Pledge of Allegiance, led by the Municipal Clerk.

At the commencement of the meeting Councilman Kownacki, Acting Mayor, read the following statement of proper notice:

WHEREAS, the lowest responsible bidder was Northeast Roof Maintenance who submitted a bid in the amount of \$238,250.00 (Total Base Bid, Alternate 1B and Alternate 2), and

BE IT FURTHER RESOLVED that the Municipal Manager is hereby authorized to draft the necessary agreement, subject to the approval of the Municipal Attorney as to form and content thereof.

## Introduction of Ordinances

Acting Mayor Kownacki read by title an ordinance entitled, "AN ORDINANCE AMENDING CHAPTER 13 OF THE LAWRENCE TOWNSHIP ADMINISTRATIVE CODE ENTITLED 'MOTOR VEHICLES AND TRAFFIC"

Mr. Krawczun stated that the Ordinance simply amends the Lawrence Township Administrative Code, specifically "Motor Vehicles and Traffic" in order to delete a designated handicapped parking space at 11 Vermont Street.

Acting Mayor Kownacki read by title an ordinance entitled, "AN ORDINANCE ESTABLISHING PROVISIONS GOVERNING SPECIAL DUTY ASSIGNMENTS FOR POLICE OFFICERS"

Mr. Krawczun stated that the Ordinance amends the established provisions governing off-duty assignments for police officers as previous discussed. The amendment will increase the hourly rate for off-duty road and/or utility construction traffic enforcement to \$75.00 per hour.

In addition, Mr. Roskos, Township Attorney, has been working from the other side of the aisle dealing with any legal issues that they may have to confront.

Mr. Krawczun stated for the December 17<sup>th</sup> Council Meeting he received a request from Eleanor Horne, Co-President Lawrence-Hopewell Trail, to make a year-end presentation to the Council on an update of the Trail activities that have been occurring in Lawrence Township as well as other parts of the Trail.

Mr. Krawczun advised that the Gregory Whitehead, Director of Public Works, has been speaking with Central Jersey Waste about the possibility of lowering the number of residents that will be required to get the Organic Waste Program started so he has nothing to report on that matter as they are still talking to them about lowering the number and indicated, as they may already know, the facility in Delaware has closed and in speaking with the owner/operator, there may be some interest in lowering that number down from the 300 required residents; but, what that number is he could not speculate.

## Public Participation (3-minute limitation per speaker) -

Mr. Joseph Mislan, 4 Sunset Road, resident of Lawrence Township for 44 years spoke about Wi-Fi and it being the new frontier with regards to technology and there being a lot to learn as it will be the new way of doing business. And, in terms of what has happened in the world of communication as they now have hand-held devices, it is important for everyone to understand that purchase of goods and payment for most goods will be done by those little hand-held devices and the speed in which this is all occurring is just phenomenal. He further discussed Wi-Fi being fixed frequencies for receiving and transmitting Gigahertz (GHz) and asked that they take notice to the name Hertz, a German Scientist from the 1800's, who was one of first pioneers to find that people could send magnetic waves a short distance and receive it at the other end and turn it back into a current; the wireless spectrum and how it came about and the impact it has made on Lawrence Township and other areas and Major Howard Armstrong who invented the tunable radio – AM then FM; a tunable frequency different from the spark frequency that covers the entire electromagnetic spectrum and asked the Council to consider how Wi-Fi will impact Lawrence as the surrounding communities exceed them with Wi-Fi technology and urged them to appoint a company or technical director to steer the Township towards Wi-Fi and to phase it into the town's commerce and everyday lives.
