April 16, 2013

The following are the Minutes of a Regular Meeting of the Lawrence Township Council that was held on Tuesday, April 16, 2013 at 6:30 P.M.

The meeting was opened with the Pledge of Allegiance, led by the Municipal Clerk. Afterwards, Mayor Kownacki asked for a moment of silence for the (3) three victims who lost their lives and the hundreds who were injured during the Boston Marathon bombing.

At the commencement of the meeting Mayor Kownacki read the following statement of proper notice:

STATEMENT OF PROPER NOTICE: "Adequate notice of this meeting of the Lawrence Township Council being held on Tuesday, April 16, 2013 has been provided through the posting of the annual meeting schedule of said Council in accordance with Section 13 of the Open Public Meetings Act".

The roll was then called as follows:

Present: Councilmembers Brame, Maffei, Powers and Mayor Kownacki.

Absent: Councilwoman Lewis. (Ms. Norcia advised that Ms. Lewis is out of

town on business.)

Also, in attendance were Richard S. Krawczun, Municipal Manager, and David Roskos, Municipal Attorney.

Special Proclamations, Recognitions and Presentations

Mayor Kownacki presented the following Proclamation honoring Christopher Thomas on being named National Youth Recreational Soccer Coach of the Year:

PROCLAMATION

WHEREAS, the Township Council of the Township of Lawrence, County of Mercer, recognizes outstanding endeavors and accomplishments; and

WHEREAS, the lifeblood of any community is its residents, past and present, who improve the quality of life for others; and

WHEREAS, occasionally one of these residents so exceeds the recognized standards of performance that special recognition is warranted; and

WHEREAS, the United States Youth Soccer Association is the governing body for more than 3 million children playing for more than 6,000 soccer clubs in the United States; and

WHEREAS, the United States Youth Soccer Association recognizes the hard work of more than 300,000 coaches with the selection of the National Youth Soccer Coach of the Year at the annual National Soccer Coaches Association of America convention; and

WHEREAS, Christopher Thomas, a Lawrence Township resident and longtime volunteer coach in the Lawrence Hamnett Soccer Association, in recognition of having dedicated enumerable hours to improving the soccer experience of so many of our children, has been selected as the National Youth Recreational Soccer Coach of the Year.

NOW, THEREFORE, BE IT PROCLAIMED by the Township Council of the Township of Lawrence, County of Mercer, State of New Jersey, that it recognizes and pays tribute to Christopher Thomas for the dedication, hard work and effort that earned his selection as National Youth Recreational Soccer Coach of the Year; and

BE IT FURTHER PROCLAIMED that this Proclamation be recorded in the official records of our municipality as recognition of Christopher Thomas' dedication to the youth of Lawrence Township.

Public Participation (5-minute limitation per speaker)

Mr. Tim Hitzel, Autism New Jersey, stated that the month of April is "Autism Awareness Month" and that Autism New Jersey is the largest statewide network of parents and professionals who dedicate and improve the lives of individuals with autism. He then introduced Ellen Schisler, Director of Development, who was in attendance and works with the organization and advised that he has been involved with the organization for a little over 13 years, as his son David was diagnosed with the autism at the young age of 18-months, and Autism New Jersey, formerly known as COSAC, was the one organization they went to immediately for assistance.

Mr. Hitzel proceeded to speak about the number of children affected by autism and the profound impact that the developmental disorder has on adolescents and adults nationally and in New Jersey and advised that he was a former member of the Board of Trustees but he now sits on the Charitable Foundation for Autism New Jersey and they are having their annual Bicycle Ride for Autism at Brookeville Community College on June 8th and he hopes everyone can attend. Further, Ellen Schisler and Kathy Moore, Secretary to the Board of Trustees, who both reside in Lawrence Township, assist in organizing other events such as the annual event that takes place in September at Captain Paul's Firehouse Dogs located on Princeton Pike to help bring awareness to autism and raise money for the organization and the "Walk for Autism" event that takes place at Mercer County Community College that benefits Autism Speaks. He then thanked the Council for their time.

Mr. Chip Hoever, Wilkin Management Group, stated he a representative of the management firm for Ventana at Lawrenceville Condominium Association, Inc. and on the Agenda under Resolutions 17-G the builder, Denow Associates, has requested the release of the performance bonds and his firm has come to an agreement with the builder and they are happy to move forward now; so, they are respectfully requesting that the Council grant the release of the bonds. He then thanked the Councilmembers for their time.

Mr. James Kiernan, 5 Alcazar Avenue, stated he has been a citizen of Lawrence for about 6 years and for the past 4 years he has been getting what he did not realize was a courtesy credit on his water bill to fill his pool as he has an outdoor pool above ground and at the last meeting where property value increases were discussed he spoke with Mr. Krawczun who spent about 5-minutes explaining to him how the Township has really tightened their budget and doing as much as they can to work within the budget constraints. He indicated he also spoke with Councilman Brame regarding the matter and he still does not understand the logic between the all or nothing attitude for those who fill their pool once a year being allowed a one-time courtesy credit on their sewer bill... not their water bill; but, instead, as a citizen, they are forcing him to go out and spend hundreds of dollars to get a separate meter installed for approximately a \$70 credit which he receives once a year, which would take him several years recuperate.

Mr. Kiernan advised that Mr. Krawczun's response to that is that they cannot give him an annual credit each year as it would not be fair to force other residents to go out and get a meter while he continues to receive a special break on his sewer bill, and his explanation to Mr. Krawczun's response is those people obviously do not need a courtesy credit on their bill being they are using the water for other uses – such as watering their lawns and he only uses the water once a year to fill his pool; therefore, he does not see the big deal in them giving him a one-time courtesy credit for water that does not go down the sewer and proceeded to reiterate his lack of understanding as why he should spend

hundreds of dollars on a meter and Township's hardline approach of not giving him the courtesy credit and a reasonable explanation as to why.

Mr. Krawczun stated that he did speak with Mr. Kiernan and it is correct that he did not approve a credit for the pool filling this year and indicated that the sewer bills currently out cover the second half of 2012 and Mr. Kiernan received an adjustment in 2008, 2009, 2011 and the first half 2012. And, on July 17, 2012, a letter was sent out by the Tax Collector advising him that any future credits would require a second irrigation meter for outside use. Further, the statement Mr. Kiernan made as to their conversation is accurate with regards to the Township requiring other customers who receive credits on their irrigation for outside usage to have a second meter and he believes there has been a degree of equity in the matter as they have given Mr. Kiernan the credit four times without the meter and notification last year as to the requirements for future credits and advised at some time there has to be a cutoff point and many other residents have gone through the expense and inconvenience of installing the meter to obtain the credits; otherwise, they would not have a proper account for outside water use if they just create a practice where they were doing calculations based on estimates or other types of non-meter use. An exchange of dialogue took place between Mr. Krawczun and Mr. Kiernan relative to his opposition on the matter.

There being no one else who wished to address Council, Mayor Kownacki closed Public Participation.

Review and Revisions of Agenda

Mr. Krawczun asked that Resolution 17-L on the Agenda be held out separately if the Council so chooses to act upon it so that the Township Engineer, Jim Parvesse, could make comments on it.

Adoption of Minutes

On a motion by Mr. Powers, seconded by Dr. Maffei, the Minutes of Regular Meeting of September 18, 2012 were approved without correction.

### Introduction of Ordinances

Mayor Kownacki read by title an ordinance entitled, "AN ORDINANCE AMENDING ORDINANCE NO. 2079-11 – AMENDING THE CONSOLIDATED LICENSE, PERMIT AND FEE CHAPTER OF THE TOWNSHIP ADMINISTRATIVE CODE"

Mr. Krawczun stated that the Ordinance simply amends a previously adopted fee ordinance for the purpose of adding document reproduction charges primarily applicable to documents made available by the Police Department so that the fees are consistent with the requirements of the Open Public Records Act.

Mayor Kownacki read by title an ordinance entitled, "ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF LAWRENCE ENTITLED 'LICENSES' REQUIRING THE LICENSING OF MASSAGE AND/OR SOMATIC ESTABLISHMENTS"

Mr. Krawczun stated that State law has been adopted that no longer permits municipalities to license individual massage therapists; however, local ordinances can be established for licensing of massage establishments. So, it is the recommendation of the Administration to repeal the current ordinance that regulates the licensing of massage therapists and massage establishments and establish a new ordinance that will provide the authority of either the Police or Health Department to conduct inspections and additionally it changes the licensing fee structure from a \$250 annual fee to a \$400 fee for a three year period.

Adoption of Ordinances

There was no adoption of ordinances.

Manager's Report -

Mr. Krawczun submitted invoice listings for the month of April 2013 in the amount of \$1,343,347.87.

Mr. Krawczun stated that he only have two items to report as there will be a discussion on Resolution (17-L) and the public hearing and adoption of the 2013 Municipal Budget and advised that a Notice was sent out by Trenton Water Works about high trihalomethanes levels in the water at a location in Hamilton Township and that Lawrence also received a copy of the letter which was forwarded along with information from the State Department of Health and New Jersey Department of Environmental Protection to all of the doctors and health facilities in the community. Additionally, information was sent out through

constant contact for those who are registered and the information was posted on the Township's website.

Mr. Krawczun stated that he had a preliminary meeting with Hopewell and Ewing Townships about the prospect of a shared animal shelter and they are still in early discussions on the matter as Hopewell Township may be acquiring some land that may accommodate a facility; but, for now it is just peaking their interest and ongoing discussions will continue being they have to look at both the capital contribution cost and the annual operating cost for the shelter services they are now in need of and advised that it will be some time until they reach any type of conclusion as Hopewell Township does not have actual ownership of the land. At this point they are just moving forward with the process to see if there is any interest; and, if not, they can all move forward with other plans.

Attorney's Report -

There was no Attorney's report.

Clerk's Report -

There was no Clerk's report.

Old Business -

Councilman Maffei advised Mayor Kownacki that he has a someone who is interested in the position open on the Senior Executive Committee and that he would delay disclosing her name until the application is reviewed by Council and they can make a decision on it at the next meeting.

New Business -

There was no new business.

Public Participation (3-minute limitation per speaker) –

Mr. Mark Solomon, Pepper Hamilton Law Firm, stated that he would like to comment on Resolution 17-L, but he would like to do it in the presence of Wesley Brooks, CFO, The Lawrenceville School, whose plane just landed, and he would not like to exclude him from the conversation. And, because he does not want to lose the opportunity to speak later on the issue he would like to reserve the ability, if necessary, to comment on the issue after Mr. Parvesse makes his presentation on the matter since it is one of importance to his client at The Lawrenceville School. The Council granted Mr. Solomon's request.

<u>Presentation/Discussion on the WPM & WQM Plan Amendment</u> <u>Resolution 155-13 (17-L)</u>

Mr. Parvesse stated that he would first be going through some of the exhibits pertaining to the Mercer County Wastewater Management Plan Amendment and that copies of the Resolution along with his attached report dated April 15th, were distributed to the Council and that the Plan was discussed at the Planning Board hearing last night. But, before he proceeds with the report

he would like to provide a little background on the mapping and how they got to the point of where they are today and proceeded to review the display of existing sewer service areas in Lawrence Township as well as properties within and excluded from the sewer service areas. He indicated in 1993 Lawrence Township and Ewing-Lawrence Sewage Authority (ELSA) went through a process of reexamination of the Wastewater Management Plant and during that process they approved a plan that included sewer service for the Educational Testing Service (ETS), Bristol-Myers Squibb (BMS), and the removal of a significant portion of Lawrence Township, just north of The Lawrenceville School, south of Route 206 and north of Princeton Pike. In addition, the Plan was approved by the Planning Board, Township Council and submitted to the Department of Environmental Protection (NJDEP) for approval and in 1995 the Planning Board amended the Master Plan to be consistent with that sewer service plan.

Mr. Parvesse indicated in 1997 the Township owned land adjacent to The Lawrenceville School, the Cranstoun Farm, and at that time there was potential development for the Dyson Tract so an agreement was made between the School and the Township for the School to purchase the Dyson Tract and basically have a land swap for the Cranstoun Farm. In the meantime, the Plan they submitted to DEP sat unapproved due to issues in Hopewell unrelated to Lawrence Township, so in 1998 and 1999 following the land swap ELSA pressed for DEP to approve the Plan and their response was there would be no action taken on the plan and they sent the plan back and the WMP was not changed. So, in 2008, the County started the process to create a countywide Waste Management Plan and their first step was to take the initial mapping that DEP had provided them and remove environmentally sensitive areas and create a draft starting point for the Wastewater Plan. Upon completion, it was sent to the Township for review and they, in turn, advised them of the changes between the existing and new plan, which were significant, as many of the Township's existing facilities were taken out of the current plan. Three years later they have a final draft from the County asking Lawrence to endorse the plan in hopes that the other townships will follow suit and they will have a county wide wastewater plan.

Mr. Parvesse proceeded to discuss at length their concerns regarding the Wastewater Management Plan Amendment for sewer areas for Township Parks, Township Land (not open space), Properties that have been removed (privately owned) and Properties Outside the 1993 WMP (endorsed by Lawrence Township), as well as, actions that were taken by the Planning Board in each of the general areas. In addition, he provided a detailed overview of the recommendations provided in his April 15th report for each of the sewer service areas and the process if the Council chooses to adopt the proposed resolution with their recommendations, which does <u>not</u> support the County's WPM Plan, as submitted, and indicated it is their hope that the Plan goes back to the County and State so that it can be revised to comply with their recommendations; then they can repeat the process for a re-endorsement of the plan that matches their proposal.

An at length comment, question and deliberation period took place amongst the Township Council relative to Mr. Parvesse's report on the general areas of concern related to WMP Amendment. Afterwards, Mayor Kownacki opened the floor for public comments.

Mr. Mark Solomon, Pepper Hamilton Law Firm, representative for The Lawrenceville School, provided a summary as to what took place at last night's Planning Board Meeting and a background history regarding the two properties in guestion - The Lawrenceville School and the Cranstoun Farm - which he indicated has been in the sewer service area and subject of discussion since 1977 and that the proposed changes would alter what has been in existence for more than 30 years. He then proceeded to the discuss NJDEP giving the County authority to draw wastewater management plans, conflicting/non-consistent sewer service changes between the State and County maps, which led to ongoing discussions and in 2009 the Township supporting the effort with communications to the County, The Lawrenceville School incorporating the changes in their wastewater management plan, discussions and studies that were done during that time period about possible constrained land and threatening endangered species which led to The Lawrenceville School hiring a consultant and the determination being the land was not in a constrained area and therefore included in the map, and from 2009-2013 the land that was proposed to be in the sewer service area was recently found to be, by the Township, inconsistent with 1993 WPM Amendment and that is where they are today.

Mr. Solomon continued with an overview as to what transpired between Lawrence Township and The Lawrenceville School, post 1993 to the present date, which led to the School purchasing the Dyson Tract and the land being conveyed over by the Township. He further discussed the appraised value as it relates to the properties having sewer lines and being in sewer service areas and their surprise when they received a call three weeks ago questioning why the properties are in a sewer service area when there has been years of dialogue, a very unusual history and a situation where the School would not have paid the kind of money they paid for land they could not use. Furthermore, they think the land is in the sewer service area... the land has always been in the sewer service area... and that the land should stay in the sewer service area and continued to discuss some of the changes to the zoning of the Cranstoun Farm and some of the details surrounding the property being transferred from public to private ownership.

Mr. Wesley Brooks, CFO, The Lawrenceville School, greeted the Council and apologized for not being able to attend last night's Planning Board Meeting and advised that The Lawrenceville School is not a commercial institution...they are a school...and they strive to be the finest boarding school in the world or

close to it, and they do that by taking care of their students and providing them with an exceptional education and in today's world part of an exceptional education is to teach respect for the environment with the ethic of sustainability being a core principle, as well as, a huge fixture of the school for the last 15 years, as 90-percent of their electricity comes from green sources - solar. So, in educating their kids on sustainability is a core plank and they have no wish or desire at all to see the land in question that they own be developed by anyone, including them, as their intent has been and remains to protect that land in a natural form and use it with great care. And, they have gone farther by simply allowing the land to continue to be farmed by industrial farmers; but the style of farming is not organic and is not good for the soil, therefore, they would like to improve the soil on the farm, and part of their plank on the solar farm is to create a solar field beneath the panels so that they can have a honey farm; and, because clover is the best plant to regenerate soil, the plan is once the useful life is finished on the solar field it will be removed and they will have a finer field for farming than when they first started and proceeded to discuss recent events that have taken place that would strategically allow them to execute their extensive long-term plan (35-years) in the most cost-efficient manner for educational farming exercises.

Councilman Brame stated although he is very impressed by Mr. Brooks' presentation he does have a question about it militating against the argument in support of keeping their sewers when he is really talking about keeping and preserving open space and cutting down on potential density that would be created by having sewer access that the School might contemplate at some point in the future; if not already, as it appears today they have not contemplated the development of housing. He then asked Mr. Brooks if he could help him reconcile that issue of sewer because it seems to him he should have no objection to not having sewers because of their green approach and was advised by Mr. Brooks that he is the Chief Financial Officer (CFO) and in wearing that "hat" his duty is to protect the values of the School in whatever form they may be... whether it is the value of their buildings, brand or faculty members, as they own that land with sewer service and it is worth less to them if the sewer service is taken away.

Mr. Brame further discussed The Lawrenceville School's intent of not developing the land, thereby, making sewer a non-essential entity in the development process since their plan is to go "green" and optimize the green sustainability approach and questioned how would not having sewer service affect the property value as the value seems to be secondary to their intentions for development of the use of the land and was advised by Mr. Brooks that it is not the intent of the School to develop the land as long as they own it; but, if they choose to not own the property by staying within the sewer service area protects the value the property, which benefits the school. An exchange of dialogue took place relative to pertinent matters regarding sewer services related to the Cranstoun Farm, Dyson Tract and whether or not the parcels in question are included or excluded under the 1995 Master Plan, as well as, potential

development of housing of approximately 60 to 70 units with both sewer and septic on the land.

Ms. Maria Delaney, 94 Harmony Avenue, stated that she was born and raised in Princeton, New Jersey but has resided in Lawrence Township since 1997 and she really does not know too much about the matter. But, after hearing the testimonies she supports The Lawrenceville School's position being the Township made an agreement with the school and given their alumni backing they should follow through on the agreement, as the matter could lead to litigation that they do not need or can afford at the expense of the taxpayers. Furthermore, they should want to show that Lawrence is a business-friendly community that wants to attract more businesses...not discourage business from wanting to operate in the township.

Mr. Ian Dember, 5614 Town Court South, stated that he is present tonight as a member of the public not as a member of the Planning Board and that a lot of good information has been presented on both sides regarding the stewardship of the land from The Lawrenceville School and the value for value deal with the Cranstoun Farm being of more value favoring the School. And, based on his understanding of the matter, from an environmental standpoint, sewer is more environmentally desirable as opposed to septic, therefore, keeping in line with the big issue of the School wanting to conserve the land as agricultural and proceeded on elaborate on his comments.

Prior to the Township Council voting on the Resolution, Mr. Roskos explained that the State is divided into different sewer service areas and the County is their Wastewater Management Planning entity, as Lawrence is in the Wastewater Management Plan, and the County is developing a countywide plan seeking input from individual townships that is sent to the Department of Environmental Protection (DEP) in hopes that they will adopt the plan; a process that has been ongoing statewide to essentially collect the thoughts and position of the various townships. Additional dialogue followed relative to the DEP efforts to digitize all of the paper maps in the State and being mired by glitches because of all the amendments to the maps, as well as, the County and State finally moving forward with an adoption plan after four years of deliberations.

There being no one else who wished to address Council, Mayor Kownacki closed Public Participation.

After an at length deliberation period, Resolution No. 155-13 (17-L), Authorizing the Proposed Water Quality Management Plan Amendment, was approved with language that Cherry Grove Farm, The Lawrenceville School – additional lands and Residential Properties along Route 206 would be inconsistent with the Master Plan and should be removed from the WPM Plan by the following roll call vote:
