THIS MATTER having been managed by the Court by way of a limited fairness and compliance hearing on May 12, 2021; and the parties having updated the Court on the status of the RPM application/project; and for good cause shown;

IT IS on this 24th day of MAY, 2021, **HEREBY ORDERED** that:

1. An amended fairness and final compliance hearing addressing the RPM project and the Township's overall Third Round Housing Element and Fair Share Plan shall be held on **July 21, 2021 at 9:30 am** with public notice being provided no later than thirty (30) days prior to the hearing.
2. By **June 16, 2021**, the Township shall adopt a Resolution of Need and Amendment to the Spending Plan related to the RPM project.
3. Written objections, if any, including any expert reports or exhibits to be relied on at the hearing, must be submitted to the Court and all parties of record by **July 12, 2021**.
4. By **July 16, 2021**, the Special Master shall provide his final written report to the Court, the Township of Lawrence, Defendants/Intervenors, and Interested Parties.
5. The Township of Lawrence shall continue to remain immune from builder's remedy litigation, and the inclusionary developments that have received land use and Court approvals may proceed with construction.

6. A copy of this Order shall be served upon counsel and all parties on the Township's Service List within seven (7) days of the Township's receipt thereof, and uploaded into eCourts.
