# TOWNSHIP OF LAWRENCE (1107) Descriptions of Election Districts July 11, 2019 (Revised December 12, 2023)

The following Geographic Information Systems (GIS) data resources were provided by the NJDEP Stream centerlines 2015; NJDOT Street centerlines 2015; TeleAtlas Street centerlines 2010. The parcels (2021) were provided and referenced as the interpretation made by the New Jersey Geographic Information Network (NJGIN). The municipal boundaries 2021, were provided and referenced as the interpretation made by the NJ Office of GIS (NJOIT). This source data was utilized for the preparation of the election district word description as stipulated under N.J.S.A. 19:4-13 et seq., as required by Administrative Law 13:17-3.1 for submission to the Office of the New Jersey Secretary of State (SOS).

The Township of Lawrence in the County of Mercer in the State of New Jersey is comprised of a total of Twenty (20) Election Districts. Due to population changes and other concerns documented during Census 2020, new boundaries for these Election Districts are required to meet New Jersey Statute Title 15 (NJAC: 15:10-3 Election District Maps) and Title 19 (NJSA: 19:4-13 Elections) guidelines and the Township's current needs. The new boundaries for these Election Districts are described herein.

#### **Election District One**

The First Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Lawrence-Pennington Road (County Route 546), is intersected on a point where said border intersects with the extended tax assessment block limit and property line between block 6005, lot(s) 233 and block 6006, lot(s) 1;

Thence, Northeast, following along the tax assessment block limit and property line between block 6005, lot(s) 233 and block 6006, lot(s) 1, from the physical centerline of Lawrence-Pennington Road (County Route 546) and parallel to the physical centerline of Shirley Lane, to a point where said border intersects with the tax assessment block limit and property line between block 6005, lot(s) 235 and block 6006, lot(s) 1:

Proceed, Southeast then Northeast, various courses, following along the extended tax assessment block limit and property line between block 6005, lot(s) 235 and block 6006, lot(s) 1, to a point where said border intersects with the physical centerline of Yeger Drive, which is also a point on the centerline of the Shipetaukin Creek tributary (a waterway);

Thence, Southeasterly, following along the physical centerline of Yeger Drive, from the extended tax assessment block limit and property line between block 6005, lot(s) 235 and block 6006, lot(s) 1, to a point where said border intersects with the physical centerline of Green Avenue;

Thence, Southwest then Southeast, following along the physical centerline of Green Avenue, to a point where said border intersects with the physical centerline of Trenton-Princeton Road (U.S. Highway Route #206);

Thence, Southwesterly, following along the physical centerline of Trenton-Princeton Road (U.S. Highway Route #206), to a point where said border intersects with the physical centerline of Franklin Corner Road (County Route 546) and the physical centerline of Denow Road;

Proceed, Northwesterly, various courses, following along the physical centerline of Franklin Corner Road (County Route 546), to a point where said border intersects with the physical centerline of Lawrence-Pennington Road (County Route 546);

Continue, Northwesterly, following along the physical centerline of Lawrence-Pennington Road (County Route 546), to a point where said border intersects with the extended tax assessment block limit and property line between block 6005, lot(s) 233 and block 6006, lot(s) 1, which is also the point of beginning.

# **Election District Two**

The Second Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Whitehead Road Extension (County Route 616), is intersected by the physical centerline of Brunswick Pike (Alternate U.S. Highway Route #1);

Thence, Northeast, following along the physical centerline of Brunswick Pike (Alternate U.S. Highway Route #1), crossing over the centerline of Shabakunk Creek (a waterway), to a point where said border intersects with the physical centerline of Magnetic Drive, which is an access easement;

Thence, Southeasterly, following along the extended physical centerline of Magnetic Drive, which is an access easement, crossing over the physical centerline of Brunswick Pike (U.S. Highway Route #1) then crossing over the centerline of the Delaware and Raritan Canal (a waterway), to a point where said border intersects with the centerline of Assunpink Creek (a waterway), which is also the Township of Lawrence and the Township of Hamilton, Mercer County shared border:

Thence, Southwesterly, various courses, following along the centerline of Assunpink Creek (a waterway), which is also the Township of Lawrence and the Township of Hamilton, Mercer County shared border, to a point where said border intersects with the physical centerline of Whitehead Road (County Route 616);

Thence, Northwesterly, following along the physical centerline of Whitehead Road (County Route 616), from the centerline of Assunpink Creek (a waterway), which is also the Township of Lawrence and the Township of Hamilton, Mercer County shared border, then crossing over the centerline of the Delaware and Raritan Canal (a waterway), to a point where said border intersects with the physical centerline of Brunswick Pike (U.S. Highway Route #1) and the physical centerline of Whitehead Road Extension (County Route 616);

Continue, Northwesterly, following along the physical centerline of Whitehead Road Extension (County Route 616), to a point where said border intersects with the physical centerline of Brunswick Pike (Alternate U.S. Highway Route #1), which is also the point of beginning.

## **Election District Three**

The Third Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Eggert Crossing Road, is intersected by a point on the physical centerline of Johnson Avenue;

Thence, Southeast, following along the physical centerline of Eggert Crossing Road, crossing over the centerline of the Little Shabakunk Creek tributary, to a point where said border intersects with the physical centerline of Lawrence Road (U.S. Highway Route #206);

Thence, Southwesterly, various courses, following along the physical centerline of Lawrence Road (U.S. Highway Route #206), to a point where said border intersects with the physical centerline of Lawn Park Avenue;

Continue, Southwesterly, following along the physical centerline of Lawn Park Avenue, to a point where said border intersects with the centerline of the Shabakunk Creek (a waterway), which is also the Township of Lawrence and the Township of Ewing, Mercer County shared border;

Thence, Northwesterly, various courses, following along the Shabakunk Creek (a waterway), which is also the Township of Lawrence and the Township of Ewing, Mercer County shared border, to a point where said border intersects with another point on the Township of Lawrence and the Township of Ewing, Mercer County shared border;

Thence, Northerly then Northeasterly then Northwesterly, various courses, following along the Township of Lawrence and the Township of Ewing, Mercer County shared border, to a point where said shared border intersects with the tax assessment property line between block 2325, lot(s) 9 & 10, which is also another point on the Township of Lawrence and the Township of Ewing, Mercer County shared border;

Proceed, Southeast, following along the tax assessment property line between block 2325, lot(s) 9 & 10, to a point where said border intersects with the tax assessment property line between block 2325, lot(s) 9, 10, 2 & 3;

Proceed, Northeast, following along the tax assessment property line between block 2325, lot(s) 2 & 10, to a point where said border intersects with the tax assessment property line between block 2325, lot(s) 1, 2 & 10;

Continue, Southeast, following along the extended tax assessment property line between block 2325, lot(s) 1 & 2, to a point where said border intersects with the physical centerline of Johnson Avenue;

Thence, Northeast, following the physical centerline of Johnson Avenue, to a point where said border intersects with the physical centerline of Eggert Crossing Road, which is also the point of beginning.

#### **Election District Four**

The Fourth Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Carter Road (County Route 569), is intersected by a point on the Township of Lawrence and the Township of Hopewell, Mercer County shared border;

Thence, Northeast, following along Township of Lawrence and the Township of Hopewell, Mercer County shared border, to a point where said border intersects with a point on the Township of Lawrence, Township of Hopewell and the Princeton, Mercer County shared border;

Thence, Southeast, following along the Township of Lawrence and the Princeton, Mercer County shared border, which a portion is the physical centerline of Province Line Road, crossing over the physical centerline of Rosedale Road (County Route 604) then crossing over the physical centerline of Trenton-Princeton Road (U.S. Highway Route #206), to a point where said border intersects with the physical centerline of Princeton Pike (County Route 583);

Thence, Southwest, following along the physical centerline of Princeton Pike (County Route 583), from the Township of Lawrence and the Princeton, Mercer County shared border, crossing over the physical centerline of U.S. Interstate Route #95, to a point where said border intersects with the physical centerline of Franklin Corner Road (County Route 546);

Thence, Northwest, following along the physical centerline of Franklin Corner Road (County Route 546), to a point where said border intersects with the physical centerline of U.S. Interstate Route #95;

Continue, Northwesterly, following along the physical centerline of U.S. Interstate Route #95, to a point where said border intersects with the physical centerline of Lawrence Road (U.S. Highway Route #206):

Thence, Northeasterly, various courses, following along the physical centerline of Lawrence Road (U.S. Highway Route #206), crossing over the physical centerline of Franklin Corner Road (County Route 546) then following along the physical centerline of Main Street (U.S. Highway Route #206), then following along the physical centerline of Trenton-Princeton Road (U.S. Highway Route #206), to a point where said border intersects with the physical centerline of Carter Road (County Route 569);

Thence, Northwesterly, various courses, following along the physical centerline of Carter Road (County Route 569), crossing over the physical centerline of Rosedale Road (County Route 604) then crossing over the centerline of Stony Brook tributary (a waterway), to a point where said border intersects with the Township of Lawrence and the Township of Hopewell, Mercer County shared border, which is also the point of beginning.

# **Election District Five**

The Fifth Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Spruce Street (County Route 613), which is also the Township of Lawrence and the City of Trenton, Mercer County shared border, is intersected by the physical centerline of Brunswick Avenue (Alternate U.S. Highway Route #1);

Thence, Northwest, following along the physical centerline of Spruce Street (County Route 613), which is also the Township of Lawrence and the City of Trenton, Mercer County shared border, to a point where said border intersects with a point on the Township of Lawrence and the Township of Ewing, Mercer County shared border;

Thence, Northeasterly, various courses, following along the Township of Lawrence and the Township of Ewing, Mercer County shared border, to a point where said border intersects with the centerline of Shabakunk Creek (a waterway);

Continue, Northeasterly, various courses, following along the centerline of Shabakunk Creek (a waterway), to a point where said border intersects with the physical centerline of Lawrence Road (U.S. Highway Route #206);

Thence, Southerly, various courses, following along the physical centerline of Lawrence Road (U.S. Highway Route #206), crossing over the physical centerline of Princeton Pike (County Route 583), to a point where said border intersects with the physical centerline of Brunswick Avenue/Brunswick Pike (Alternate U.S. Highway Route #1), which is also a point on the Township of Lawrence and the City of Trenton, Mercer County shared border;

Continue, Southwest, following along the physical centerline of Brunswick Avenue (Alternate U.S. Highway Route #1), which is also the Township of Lawrence and the City of Trenton, Mercer County shared border, to a point where said border intersects with the physical centerline of Spruce Street (County Route 613), which is also another point on the Township of Lawrence and the City of Trenton, Mercer County shared border and the point of beginning.

## **Election District Six**

The Sixth Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Lawn Park Avenue, is intersected by the centerline of Shabakunk Creek (a waterway), which is also the Township of Lawrence and the Township of Ewing, Mercer County shared border;

Thence, Northeasterly, following along the physical centerline of Lawn Park Avenue, to a point where said border intersects with the physical centerline of Lawrence Road (U.S. Highway Route #206) and the extended tax assessment property line between block 1905, lot(s) 2 & 3;

# Election District Six (cont'd)

Thence, Southeasterly, various courses, following along the extended tax assessment property line between block 1905, lot(s) 2 & 3, to a point where said border intersects with the physical centerline of Stella Drive:

Proceed, Northeast, following along the physical centerline of Stella Drive, to a point where said border intersects with the extended tax assessment property line between block 1906, lot(s) 1 & 25.01;

Continue, Northeast, following along the tax assessment property line between block 1906, lot(s) 1 & 25.01, from the physical centerline of Stella Drive, to a point where said border intersects with extended tax assessment property line between block 1906, lot(s) 16 & 17 and the physical centerline of Fieldboro Drive;

Proceed, Northeast, from the physical centerline of Fieldboro Drive, to the extended tax assessment property line between block 1907, lot(s) 1 & 34;

Thence, Northeast, following along the tax assessment property line between block 1907, lot(s) 1 & 34, to a point where said border intersects with the tax assessment property line between block 1907, lot(s) 12, 18 & 15:

Thence, Southwest, following along the tax assessment property line between block 1907, lot(s) 18 & 15, to a point where said border intersects with the tax assessment property line between block 1907, lot(s) 16, 18 & 15;

Thence, Southeast, following along the extended tax assessment property line between block 1907, lot(s) 16 & 15, to a point where said border intersects with the physical centerline of Princeton Pike (County Route 583);

Thence, Southwest, following along the physical centerline of Princeton Pike (County Route 583), to a point where said border intersects with the centerline of Shabakunk Creek (a waterway);

Thence, Southwesterly, various courses, following along the centerline of Shabakunk Creek (a waterway), crossing over the physical centerline of Lawrence Road (U.S. Highway Route #206), to a point where said border intersects with a point on the Township of Lawrence and the Township of Ewing, Mercer County shared border;

Thence, Northerly, various courses, following along the Township of Lawrence and the Township of Ewing, Mercer County shared border, from the centerline of Shabakunk Creek (a waterway), to a point where said border intersects with the physical centerline of Lawn Park Avenue, which is also another point on the Township of Lawrence and the Township of Ewing, Mercer County shared border and the point of beginning.

## **Election District Seven**

The Seventh Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Carter Road (County Route 569), is intersected by a point on the Township of Lawrence and the Township of Hopewell, Mercer County shared border;

Thence, Southeasterly, various courses, following along the physical centerline of Carter Road (County Route 569), crossing over the centerline of Stony Brook (a waterway), crossing over the physical centerline of Rosedale Road (County Route 604), to a point where said border intersects with the physical centerline of Trenton-Princeton Road (U.S. Highway Route #206);

Continue, Southwesterly, various courses, following along the physical centerline of Trenton-Princeton Road (U.S. Highway Route #206), to a point where said border intersects with the physical centerline of Cold Soil Road;

Proceed, Northwest, following along the physical centerline of Cold Soil Road, to a point where said border intersects with the physical centerline of Keefe Road;

Proceed, Southwest, following along the physical centerline of Keefe Road, to a point where said border intersects with the physical centerline of Yeger Drive;

Thence, Southeast, following along the physical centerline of Yeger Drive, to a point where said border intersects again with the physical centerline of Keefe Road;

Thence, Southwest, following along the physical centerline of Keefe Road, to a point where said border intersects with the physical centerline of Federal City Road and the physical centerline of Lawrenceville-Pennington Road (County Route 546);

Thence, Northwest, following along the physical centerline of Lawrenceville-Pennington Road (County Route 546), to a point where said border intersects with a point on the Township of Lawrence and the Township of Hopewell, Mercer County shared border;

Thence, Northeasterly, various courses, following along the Township of Lawrence and the Township of Hopewell, Mercer County shared border, crossing over the physical centerline of Blackwell Road, to a point where said border intersects with the physical centerline of Carter Road (County Route 569), which is also another point on the Township of Lawrence and the Township of Hopewell, Mercer County shared border and is also the point of beginning.

# **Election District Eight**

The Eighth Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Lawrence Road (U.S. Highway Route #206), is intersected by a point on the physical centerline of Darrah Lane;

Thence, Southeast, following along the physical centerline of Darrah Lane, to a point where said border intersects with the physical centerline of Princeton Pike (County Route 583);

Thence, Southwest, following along the physical centerline of Princeton Pike (County Route 583), to a point where said border intersects with the extended tax assessment property line between block 1907, lot(s) 16 & 15;

Thence, Northwest, following along the extended tax assessment property line between block 1907, lot(s) 16 & 15, from the physical centerline of Princeton Pike (County Route 583), to a point where said border intersects with the tax assessment property line between block 1907, lot(s) 18, 16 & 15;

Thence, Northeast, following along the tax assessment property line between block 1907, lot(s) 18 & 15, to a point where said border intersects with the tax assessment property line between block 1907, lot(s) 18, 12 & 15;

Thence, Northwest, following along the tax assessment property line between block 1907, lot(s) 18 & 12, to a point where said border intersects with the tax assessment property line between block 1907, lot(s) 1 & 34:

Continue, Northwest, following along the extended tax assessment property line between block 1907, lot(s) 1 & 34, to a point where said border intersects with the physical centerline of Fieldboro Drive,

Proceed, Northwest, following along the extended tax assessment property line between block 1907, lot(s) 1 & 34, from the physical centerline of Fieldboro Drive, to a point where said border intersects with the extended tax assessment property line between block 1906, lot(s) 16 & 17,

Continue, Northwest, following along the tax assessment property line between block 1906, lot(s) 16 & 17, to a point where said border intersects with the tax assessment property line between block 1906, lot(s) 1 & 25.01:

Thence, Northwest, following along the extended tax assessment property line between block 1906, lot(s) 1 & 25.01, to a point where said border intersects with the physical centerline of Stella Drive;

Continue, Southwest, following along the physical centerline of Stella Drive, to a point where said border intersects with the extended tax assessment property line between block 1905, lot(s) 3 & 2;

Thence, Northwest, following along the tax assessment property line between block 1905, lot(s) 3 & 2, from the physical centerline of Stella Drive, to a point where said border intersects with the extended tax assessment property line between block 1905, lot(s) 3 & 2 and the physical centerline of Lawrence Road (U.S. Highway Route #206);

Thence, Northeasterly, various courses, following along the physical centerline of Lawrence Road (U.S. Highway Route #206), to a point where said border intersects with the physical centerline of Darrah Lane, which is also the point of beginning.

## **Election District Nine**

The Ninth Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Brunswick Avenue/Brunswick Pike (Alternate U.S. Highway Route #1), is intersected by a point on the physical centerline of Lawrence Road (U.S. Highway Route #206), which is also a point on the Township of Lawrence and the City of Trenton, Mercer County shared border;

Thence, Northwest, following along the physical centerline of Lawrence Road (U.S. Highway Route #206), crossing over the physical centerline of Princeton Pike (County Route 583), to a point where said border intersects with the centerline of Shabakunk Creek (a waterway);

Thence, Northeasterly, various courses, following along the centerline of Shabakunk Creek (a waterway), to a point where said border intersects with a point on the physical centerline of Princeton Pike (County Route 583);

Thence, Southwest, following along the physical centerline of Princeton Pike (County Route 583), to a point where said border intersects with a point on the extended tax assessment property line between block 1502, lot(s) 35 & 36;

Thence, Southeast, following along the tax assessment property line between block 1502, lot(s) 35 & 36, from the physical centerline of Princeton Pike (County Route 583), to a point where said border intersects with a point on the tax assessment property line between block 1502, lot(s) 35, 36 & 3;

Continue, Southwest, following along the tax assessment property line between block 1502, lot(s) 35 & 3, to a point where said border intersects with a point on the tax assessment property line between block 1502, lot(s) 35, 28 & 3;

Thence, Southeasterly, various courses, following along the tax assessment property line between block 1502, lot(s) 28 & 3, crossing over the terminus of the physical centerline of Hopewell Avenue, to a point where said border intersects with a point on the tax assessment property line between block 1502, lot(s) 6 & 7;

Continue, Southeast, following along the extended tax assessment property line between block 1502, lot(s) 6 & 7, to a point where said border intersects with a point on the physical centerline of Brunswick Pike (Alternate U.S. Highway Route #1);

Thence, Southwest, following along the physical centerline of Whitehead Road Extension (County Route 616), crossing over the physical centerline of Brunswick Pike (U.S. Highway Route #1) then crossing over the centerline of the Delaware and Raritan Canal (a waterway), to a point where said border intersects with the centerline of Assunpink Creek (a waterway), which is also the Township of Lawrence and the Township of Hamilton, Mercer County shared border;

Thence, Southwesterly, various courses, following along the centerline of Assunpink Creek (a waterway), which is also the Township of Lawrence and the Township of Hamilton, Mercer County shared border, to a point where said border intersects with the Township of Lawrence, Township of Hamilton and the City of Trenton, Mercer County shared border;

Thence, Northwesterly, following along the Township of Lawrence and the City of Trenton, Mercer County shared border, crossing over the centerline of the Delaware and Raritan Canal (a waterway), to a point where said border intersects with the physical centerline of Brunswick Avenue/Brunswick Pike (Alternate U.S. Highway Route #1) and the physical centerline of Lawrence Road (U.S. Highway Route #206), which is also another point on the Township of Lawrence and the City of Trenton, Mercer County shared border and the point of beginning.

#### **Election District Ten**

The Tenth Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Lawrenceville-Pennington Road (County Route 546), is intersected by a point on the Township of Lawrence and the Township of Hopewell, Mercer County shared border;

Thence, Southeasterly, following along the physical centerline of Lawrenceville-Pennington Road (County Route 546), to a point where said border intersects with the physical centerline of Lawrencia Drive;

Continue, Southwesterly then Southeasterly, following along the physical centerline of Lawrencia Drive, to a point where said border intersects with the physical centerline of Winthrop Road;

Thence, Southwest then Northwest, following along the physical centerline of Winthrop Road, to a point where said border intersects with the physical centerline of Eric Court;

Thence, Southwest, following along the physical centerline of Eric Court, to a point where said border intersects with the extended tax assessment property line between block 5401, lot(s) 125.01 &145;

Thence, Northwest, following along the tax assessment property line between block 5401, lot(s) 125.01 &145, from the physical centerline of Eric Court, to a point where said border intersects with the tax assessment property line between block 5401, lot(s) 125.02, 128 & 143;

Proceed, Southwest, following along the tax assessment property line between block 5401, lot(s) 125.02 & 128, to a point where said border intersects with the tax assessment property line between block 5401, lot(s) 125.02, 128 & 125.03;

Thence, Northwest, following along the tax assessment property line between block 5401, lot(s) 128 & 125.03, to a point where said border intersects again with the tax assessment property line between block 5401, lot(s) 127, 128 & 125.03;

Thence, Southwesterly, following along the tax assessment property line between block 5401, lot(s) 127 & 125.03, to a point where said border intersects with the tax assessment property line between block 5401, lot(s) 125.06, 120.02 & 125.05.1;

Thence, Northwest, following along the extended tax assessment property line between block 5401, lot(s) 120.02 & 125.05.1, to a point where said border intersects with the physical centerline of Federal City Road;

## Election District Ten (cont'd)

Thence, Southwesterly, following along the physical centerline of Federal City Road, crossing the physical centerline of Denow Road, to a point where said border intersects with the physical centerline of U.S. Interstate Route #95;

Thence, Northwest, following along the physical centerline of U.S. Interstate Route #95, to a point where said border intersects with the Township of Lawrence and the Township of Hopewell, Mercer County shared border;

Thence, Northeast, following along the Township of Lawrence and the Township of Hopewell, Mercer County shared border, to a point where said border intersects with the physical centerline of Lawrenceville-Pennington Road (County Route 546), which is also the point of beginning.

# **Election District Eleven**

The Eleventh Election District of the Township of Lawrence shall include all of the territory and inhabitants thereof contained, in an area which is bounded and described as follows:

Beginning at a point where the physical centerline of Lawrence Road (U.S. Highway Route #206), is intersected by a point on the physical centerline of Darrah Lane;

Thence, Northeast, following along the physical centerline of Lawrence Road (U.S. Highway Route #206), to a point where said border intersects a point on the centerline of Little Shabakunk Creek (a.k.a. Five Mile Run, a waterway);
