LAWRENCE TOWNSHIP ADMINISTRATIVE CODES PERTAINING TO DOGS & CATS & WATERFOWL

89-3 RUNNING AT LARGE

IT SHALL BE UNLAWFUL FOR ANY PERSON WHO OWNS, KEEPS OR HARBORS A DOG OR DOGS TO PERMIT THE SAME TO RUN AT LARGE OR TO BE UPON THE STREETS, HIGHWAYS OR OTHER PUBLIC PLACES, OR UPON PRIVATE PROPERTY OTHER THAN THAT OF THE OWNER, OR DESIGNATED BY THE TOWNSHIP AS A DOG RUN, IN THE TOWNSHIP, UNLESS CONTROLLED BY A LEASH, NOT TO EXCEED SIX (6) FEET IN LENGTH, SECURELY FASTENED TO THE DOGS COLLAR OR HARNESS.

89-4 POOPER SCOOPER

ANY PERSON OTHER THAN A VISUALLY HANDICAPPED HANDLER OF A GUIDE DOG WHO HAS CHARGE OF A DOG SHALL BE RESPONSIBLE FOR THE PROMPT AND EFFICIENT REMOVAL AND SANITARY DISPOSITION OF THE FECES OF THE DOG FROM ANY PUBLIC PLACE OR ANY PRIVATE PLACE UNLESS EXPRESSLY PERMITTED BY THE OWNER.

TWP. 89-7 STATE 4:19-15.2 DOG LICENSE

ALL DOGS, SEVEN (7) MONTHS OR OLDER, KEPT WITHIN THE TOWNSHIP OF LAWRENCE ARE REQUIRED TO BE LICENSED. DOG LICENSES ARE TO BE RENEWED DURING THE MONTH OF JANUARY OF EACH YEAR. CURRENT RABIES VACCINATIONS ARE REQUIRED FOR LICENSING.

89-27 CAT LICENSE

ALL CATS, INDOOR OR OUTDOOR, SEVEN (7) MONTHS OR OLDER, KEPT WITHIN THE TOWNSHIP OF LAWRENCE ARE REQUIRED TO BE LICENSED. CAT LICENSES ARE TO BE RENEWED DURING THE MONTH OF SEPTEMBER OF EACH YEAR. CURRENT RABIES VACCINATIONS ARE REQUIRED FOR LICENSING.

258-3D NOISE DISTURBANCE BY ANIMALS AND BIRDS

THE KEEPING OF ANIMALS OR BIRDS WHICH, BY CAUSING FREQUENT OR LONG-CONTINUED NOISE, DISTURBS THE COMFORT OR REPOSE OF ANY PERSON IN THE VICINITY (FOR THE PURPOSE OF THIS SECTION, A NOISE DISTURBANCE FROM A BARKING DOG SHALL BE DEFINED AS THAT CREATED BY A DOG BARKING CONTINUALLY FOR TEN (10) MINUTES OR INTERMITTENTLY FOR THIRTY (30) MINUTES UNLESS PROVOKED

89-34 FEEDING WATERFOWL

IT SHALL BE UNLAWFUL FOR ANY PERSON TO FEED THE WATERFOWL ON ANY MUNICIPAL PROPERTY OR PARK LAND.
