**ORDINANCE APPROPRIATING \$5,185,000 FROM THE CAPITAL
IMPROVEMENT FUND FOR VARIOUS CAPITAL IMPROVEMENTS IN AND
BY THE TOWNSHIP OF LAWRENCE, IN THE COUNTY OF MERCER,
NEW JERSEY**

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LAWRENCE, IN THE COUNTY
OF MERCER, NEW JERSEY AS FOLLOWS:**

**Section 1. \$5,185,000 is hereby appropriated from the Capital Improvement Fund for various
capital improvements in and by the Township of Lawrence, in the County of Mercer, New Jersey (the
“Township”) as set forth below:**

A. Various Computer and Office Equipment consisting of but not limited to: Township wide Computer Equipment and Software; Police Computer Equipment, Software, WiFi Upgrades, UPS Batteries	\$140,000
B. Acquisition of Various Public Safety Equipment consisting of but not limited to: Body/Vehicle Cameras; Handguns	\$172,000
C. Improvements to Municipal Buildings: Various Municipal Building Improvements; Paint and Carpet Police/Court Facility; Homefront (295 Eggerts Crossing Road) Improvements including Gym Floor and Painting; Townhall Employee Breakroom Renovation; Townhall Lower Level Nurse/Patient Room Remodel; Vehicle Maintenance Garage Air Scrubber; Booking Room/DUI Room Improvements; Police Breakroom Improvements	\$3,763,000.00
D. Acquisition of Fire/Rescue Equipment: Brush Truck (2 of 2); Ambulance; Turnout Gear	\$315,000
E. Acquisition of Various Communication Equipment: Fire Mobile and Fixed Radios	\$75,000
F. Acquisition of Various Public Works Equipment: Vehicle Maintenance Shop Truck; Recreation Electric Vehicle; Police Vehicle Paint/Car Wrap	\$210,000
G. Various Park and Recreational Facility Improvements: Village Park Basketball Courts Resurfacing/Equipment	\$100,000
H. Acquisition of Fire Apparatus: Ladder Truck (1 of 3); Tanker with Pump (1 of 4)	\$410,000
TOTAL	\$5,185,000

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by law.
