Ordinance No. 2468-24

ORDINANCE PROVIDING FOR VARIOUS ROAD IMPROVEMENTS (MILL AND OVERLAY INCLUDING ALL WORK AND MATERIALS) IN AND BY THE TOWNSHIP OF LAWRENCE, IN THE COUNTY OF MERCER, NEW JERSEY, APPROPRIATING \$3,069,180 IN CAPITAL IMPROVEMENT FUNDS

BE IT ORDAINED by the Township Council of the Township of Lawrence, in the County of Mercer, State of New Jersey as follows:

Section 1. The improvement described in Section 2 of this ordinance is hereby authorized to be undertaken by the Township of Lawrence, in the County of Mercer, New Jersey is hereby appropriated in the amount of \$3,069,180 in Capital Improvement Funds.

Section 2. The purpose for which the funds are provided is (1) the 2024 Road improvement program consisting of mill and overlay Princeton Pike Congestion Improvements (Princeton Pike & Fackler Road, Princeton Pike & Province Line Rd), Glenbrook Court, Gainsboro Road, Gedney Road & Fieldboro Drive, Tiffany Woods Development, Glenn Avenue (Stonicker to Darrah Lane) & Stoniker Drive (Princeton Pike to Allen Lane), Huron Way, Ontario Way & Winnipeg Lane, Lombard Avenue & Shelmet Lane, Brearley Avenue, Drexel Avenue & Fernwood Lane, Renee Court, and other roads identified in the Road Improvement Program maintained by the Township Engineer, including Road Striping; (2) Concrete Improvements incidental to overlay and all work and materials necessary therefore or incidental thereto; and (3) Guiderails/Traffic Signal Improvements incidental to overlay.

Section 3. The capital budget of the Township of Lawrence is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. The following additional matters are hereby determined, declared, recited and stated:

(a) The purposes described in Section 2 of this ordinance are not current expenses. They are all improvements that may be lawfully undertaken as general improvements, and no part of the costs thereof has been or shall be specially assessed on property specially benefited thereby.

(b) An aggregate amount not exceeding \$30,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated costs indicated herein for the purpose of improvements.

Section 6. This ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by law.
