ORDINANCE APPROPRIATING \$1,930,325.00 FROM THE CAPITAL IMPROVEMENT FUND FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF LAWRENCE, IN THE COUNTY OF MERCER, STATE OF NEW JERSEY

BE IT ORDAINED by the Township Council of the Township of Lawrence, in the County of Mercer, State of New Jersey as follows:

Section 1. \$1,930,325.00 is hereby appropriated from the Capital Improvement Fund for various capital improvements in and by the Township of Lawrence, in the County of Mercer, New Jersey (the "Township") as set forth below:

C. Improvements to Municipal Buildings: Buildings & Grounds Fresh-air Ventilation/Heat Exchange System, Clerk Office Redesign	\$192,000
D. Acquisition of Fire/Rescue Equipment: Fire Services Turn-out Gear, Fire Services SCBAs	\$190,000
E. Acquisition of Various Communication Equipment: Fire Services Portable Radios & Pagers, Fire Services Fire Reporting System	\$113,000
F. Acquisition of Various Equipment: Police e-Bikes, Emergency Management 4x4 Crewcab Emergency Vehicle, Streets & Roads Garbage Truck with Snow Removal Equipment, Streets & Roads Pick-up Truck with Snow Removal Equipment, Vehicle Maintenance Four Post Mobile Vehicle Lift, Streets & Roads Trash Carts, Office on Aging Van, Fire Services (3) Fire Company Deputy Chief Vehicles	\$823,325
G. Acquisition of Fire Apparatus: (multi-year) Ladder Truck, Fire Truck Restoration	\$190,000
TOTAL	\$1,930,325

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by law.
